

Goodwheel Skatepark Participant Agreement and Express Assumption of Risk Associated with Skate Park Use and Related Activities

1) I acknowledge that participation in skateboarding, inline skating, and other variations of these are inherently dangerous. These known and unanticipated risks can result in injury to myself and my property including death, paralysis, brain damage, broken bones, and permanent disability. **The risks include but are not limited to:**

- Collision with other participants, staff, walls, floor, both padded and non-padded fixed objects, supports, and obstacles
- Imperfections in the course including the metal footing on the ramps, the ramp surfaces, and rocks or other objects on the floor (The park is inspected and well maintained, but all risks can never be eliminated.)
- My own equipment failure or the failure of others' equipment
- Being hit by skateboards or other equipment even while not participating
- Heat stroke or other conditions caused by climate

2) I agree to always wear a helmet. (A helmet cannot guarantee my safety, but will reduce some risk of injury.)

3) I expressly agree and promise to accept and assume all the risks existing in this activity. My participation is purely voluntary, and I elect to participate in spite of the risks.

4) I certify that I have adequate insurance to cover damages occurring while participating or agree to bear the cost myself.

GOODWHEEL SKATEPARK ABSOLUTLEY WILL NOT PAY FOR INJURIES THAT OCCUR AT THE PARK!

5) If injury occurs, and the staff deems it necessary to call emergency medical services, I agree to pay for any resulting charges.

1) **In consideration for being able to participate, I HEREBY RELEASE AND HOLD HARMLESS WITH RESPECT TO ANY AND ALL INJURY, DISABILTY, DEATH, OR LOSS OR DAMAGE TO PERSON OR PROPERTY, WHETHER CAUSED BY NEGLIGENCE OR OTHERWISE,** the following persons and entities, herein referred to as releasees: **Goodwheel Skateboards LLC, Joey Hambuchen (owner), and staff.**

2) I agree to release the releasees, their officers, directors, employees, representatives, agents, and volunteers from liability and responsibility whatsoever and for any claims or causes of action that I, my estate, heirs, survivors, executors, or assigns may have for personal injury, property damage, or wrongful death arising from the above activities whether caused by active or passive negligence of the releasees or otherwise. By executing this document, I agree to hold the releasees harmless and indemnify them in conjunction with any injury, disability, death, or loss or damage to person or property that may occur as a result of my engaging in the above activities.

3) By entering into this Agreement, I am not relying on any oral or written representation or statements made by the releasees, other than what is set forth in this Agreement.

4) This agreement shall apply to any and all above mentioned events occurring at any time after the execution of this agreement.

This release shall be binding to the fullest extent permitted by law. If any provision of this release is found to be unenforceable, the remaining terms shall be enforceable.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, I FULLY UNDERSTAND ITS TERMS, I UNDERSTAND THAT I HAVE GIVEN UP LEGAL RIGHTS BY SIGNING IT, AND I SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
